#### **Doggie Dog World (DDW) Boarding Cancellation Policy**

DDW requires advanced notice for cancellations and changes to drop-off and pick-up dates for boarding reservations as follows:

To receive a refund or account credit for your \$60 deposit, you must give 24-hour notice by phone, text, or email to cancel or change your pup's reservation.

Your \$60 deposit is non-refundable if you cancel same-day or are a "no-call/no-show" for your reservation. DDW has now reached full capacity in all playgroups. If you do not show up for your reservation you are taking a spot away from someone on the waitlist.

Holiday Boarding - A 50% deposit is due at the time of scheduling. 7 days' notice for reservation cancellations for holidays is required to receive a full refund. Cancellations made after the 7-day period before the holiday and "no-call/no-shows" will forfeit their 50% deposit.

#### \*\*\*Dog Daycare and Boarding Agreement\*\*\*

**Requirements:** All canines must be up-to-date on all vaccines, including **Bordetella**, **Rabies**, and **DHPP**. Official vaccination records must be provided prior to entry into daycare or boarding and must be administered at least 3 days prior to either service. We reserve the right to refuse acceptance to a pet at check-in for any reason, including, but not limited to, the pet appearing sick, injured, in pain or their behavior may jeopardize the health and safety of other pets or our staff. If your pet has a medical condition or is on any medication please let our staff know so they can ensure proper accommodations can be made.

- You have the option to name an adult (18 or older) as your agent or emergency contact. This person should not be someone who is traveling with you if you are leaving town. If we cannot reach you, you authorize us to contact your agent. You agree that your agent shall have your complete authority to make any and all decisions, including those related to the health of your pet and the expenditure of funds for or on your behalf of you and your pet.
- **Emergencies:** In cases DDW deems serious, we will take your pet to the nearest emergency vet before trying to contact you. You assume responsibility for medical costs. If your pet becomes ill or injured in what is deemed by our employees as a non-emergency, and we are unable to reach you, please indicate your wishes below:

- Liability: You acknowledge and agree that in the unlikely event, that your pet is injured by another pet you release DDW and its employees from any liability for such injury. If your pet injures another pet, you will be solely responsible for any injury to the other pet(s) as well as your own pet and you release DDW and its employees from any liability for such injury. You understand that your pet can become ill even if vaccinated. You assume all risks and accept the responsibility for all costs for treatments. You further agree to hold the owners and employees of DDW harmless from expenses incurred for such treatment.
- Property Damage: If your pet destroys any property of DDW during his/her stay with us, you acknowledge and agree that you are responsible for charges incurred to replace such items.

- Payment for Services: You agree to pay DDW for the services we provide to your pet during each visit at the rates set forth by DDW, rates are subject to change without notice.
- Dog Daycare and Boarding: Please be advised that your dog will co-mingle with other dogs during their time with us. Infectious diseases, minor injuries, dog bites, etc. may occur even when properly vaccinated and dogs deemed "dog-friendly" interact with each other.
- Personal Items: Do not bring items with your dog that are valuable or irreplaceable.
   DDW is not responsible for loss or damage to personal items or toys left with your pet.
   All medications must be in a container with a current prescription label from your veterinarian. Supplements not labeled for animals or prescribed by a veterinarian will only be given with your permission and you assume responsibility for their use.
- Pets not picked up on departure date: If you or your agent do not pick up your pet on the agreed date you hereby authorize DDW to continue to provide the services set forth in the agreement at your expense.
- Abandonment: If your pet is deemed abandoned under local, state, or federal laws DDW will attempt to contact you and/or your agent(s) by telephone or in writing advising you that if your pet is not picked up within a reasonable time period set by DDW your pet will be surrendered to Anchorage Animal Care and Control. In Alaska, abandoning an animal for more than 72 hours is illegal. You understand that you may lose ownership of your pet(s) under the circumstances. If you fail to pick up your pet for any reason you release DDW from all further liability and responsibility for your pet. You shall remain liable for all unpaid charges, including court costs and attorney's fees incurred in the collection of charges.
- Miscellaneous Provision: We reserve the right to use photographs or video footage of your pet taken during their stay. These images may be used for social media purposes.
   This agreement will remain in effect for any current or future pets you may bring to DDW until the time it is updated.
